FAULTY CHARGE PRESSURE ERROR CODES

Should warranty repairs be required, parts and labour will be provided free of charge during normal working hours at Barloworld Equipment's premises or at any other authorized premises. The warrantor shall retain the right to install new or repaired parts.

In the event of it being necessary to dismantle any equipment in order to compile a quotation, the following conditions shall apply:

1. Barloworld Equipment will dismantle the equipment to such an extent it deems necessary in order to prepare the quotation.
2. The Customer shall be liable for the cost of the dismantling of the equipment at the labour charge-out rate.
3. Should the quotation not be accepted, the Customer shall accept the component loosely assembled without seals, locks, gaskets and shall collect the components as soon as possible after notification by Barloworld Equipment.
4. All non-Caterpillar parts and parts reused, as per customer request, will not be covered by the warranty.

Barloworld Reman Conditions

- A. All used cores to be returned back to the BRC (Barloworld Reman Centre) within 30 days after receipt of New Remanufactured core. Failure to return and receive the core in the BRC within this time frame will result in a ZERO core credit and the Customer being charged the full amount with no credits applicable thereafter.
- B. Metal stands and covers - core to be returned to the BRC on the stand and with the shipping covers that the component was supplied with. (Cost to Customer if stand/covers are not returned).
- C. All fluids to be drained before return to the BRC.
- D. Transport Costs not Included in the price.
- E. If any component is returned with missing or non-Caterpillar parts, then the replacement parts will be for the Customer's account.
- F. Final confirmation of the core credit will be confirmed at the BRC.

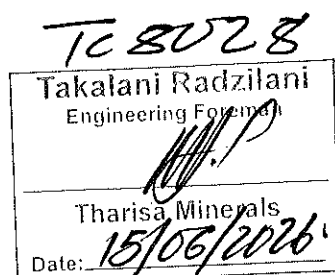
